John Roeder- Fire & EMS Department

Informed the Trustees that the Marks & VHF radio systems they approved for purchase in September 2016 was now installed and operational. Expressed the benefit of being able to monitor the two way communications. Stated the Firefighter 36 hour training class was proceeding on schedule.

Reviewed the number of EMS and Fire runs for the department for November to date. There were 119 total, with Station #58 handling 80 runs, Station #72 handling 39. The District calls were 13 for Rockway, 41 for Station #58 and 49 for Station #72.

Mr. Foley- Inquired if the EMS billing system was improved or working more efficiently?

Chief Roeder- He believes the billings are currently up to date and requested that Mr. Hively address the billing receipts.
