Stephanie Dunlap This is case S-2023-02 the owners and applicants are Lindsey and Molly Duncan. Their request is to rezone approximately 10 acres from OR1 to A. There is split zoning on this parcel. The request was reviewed by the technical review committee at the county. The engineers have no objection to the request, but did comment on the access to the property and the owners are seeking to get their access for the property. They will also need to speak with ODOT to make sure there are no issues with a new access.

The staff recommendations: the proposed rezoning from OR-1 to A will eliminate split zoning on the property at 5050 S Charleston Pike by identifying the entire property as Agricultural. The current owner of the property does not have an office in their residence, and therefore, the OAR-1 zoning is no long required. If approved, the rezoning will be ensuring lower intensity use at the property by removing the commercial office use.

Staff recommends that the Applicant's request to rezone 10 acres from OR-1 to A be approved subject to approval from the Clark County Engineer's Office and/or ODOT as required.
