	Deputy/ Jake Shaw I have turned in some stats for the Township, (8 hours a day, 5 days a week) since January 1, 2022: 1254 calls for

service, 185 assists, 194 reports, 100 traffic stops with 51 citations, 49 warrants, and 78 arrests. Bethel Township just passed a levy for a second Deputy, and Springfield Township has double the calls.

Helpoke with Chief King from Bethel Township about their Levy of 1.75 Mill. They have 2 Deputies, and they own both of their cars with those funds.

Springfield Township now rents law enforcement from Clark County, for 5 years and 1 Deputy at the current rate costs \$685,306.

For the Township to buy the equipment for a Deputy \$75,000 to \$80,000 for each vehicle, and wages and benefits would be \$274,000 per year for 2 Deputies.

Tim Foley On a .5 Mill Levy the Township receives approximately \$116,000 per year, so if we place a 1 Mill Levy on the ballot in November that would generate approximately \$232,000 and if that passed we could add a second Deputy, and not have that much come out of General Fund.

We came in the year with \$3 Million in the 6 funds, and we were \$200,000 shy of what we came in with. So we spent more than we brought in as revenue.	
John Roeder This is what I am saying. We need to do our research on what we need and the cost before we take this to the public.	
Jim Scoby Did raising our wages help?	
Dave Nangle It has helped, but we don't have experience to pick from. There are full time jobs out there and that's where they're going. Across the county there is a shortage.
