Jake Shaw Our stats for August were: 73 calls for service, 3 assists, 23 reports, 13 traffic stops, 5 citations, and 21 arrests with 5 crash reports.

Multiple law enforcement agencies teamed up on August 24, 2023, to focus on drug and traffic violations along with violent repeat offenders in Clark County. The blitz resulted in 68 total incidents in Springfield and Springfield Township.

There were 2 OVI arrests; 8 felony arrests, 5 felony drug arrests, 1 misdemeanor drug arrest, 8 warrants served and 2 seized firearms.
