BE IT FURTHER RESOLVED by the Township Trustees to request a speed limit change on Burnett Road and Crabill Road.

It has recently come to the attention of the Springfield Township Board of Trustees that the 40 mph speed limit signs on the following roads are not enforceable by local law enforcement:

- Burnett Road: between Crabill Road and the Springfield Corporation limits (near Sunset Avenue);
- Crabill Road: between Selma Pike and E. Possum Road

According to Ohio Revised Code Section 4511.21(Speed Limits), both of these roads meet the criteria for a prima-facie lawful speed of 55 mph. The Springfield Township Board of Trustees has requested that the Clark County Engineer's Office perform speed zone studies on the aforementioned roads. Preliminary results indicate a warranted speed limit of 45 mph for each roadway. However, it is this Board's opinion that the speeds should be established at 40 mph for the safety of the local residents and the traveling public. We offer the following reasons for consideration:

- Close proximity to K-12 Schools which causes increased school traffic on these roads;
- Multiple bus stop locations along Crabill Road and Burnett Road;
