Vicki Gundolf Billy has been working on getting estimates for an attachment for the Excavator to mix cement for Vale Cemetery and would be able to utilize this for the Road Department also. We discussed just having a concrete truck bring in mixed concrete but our roads at the cemetery are not capable of handling that much wear and tear and weight.
