**Tim Foley** Our Special Guest is Michael Foley. I invited Michael since he has experience with the ARP Program at the County Level. He is not representing the County or Legal Counsel today. He is simply providing his opinion as my special guest.

#### **Operational 2022 Segment of the Meeting**

John Roeder I meet with Chief Deputy and Deputy from Clark County Sheriff Department on having a Springfield Township Deputy. They brought in a contract on how this service works. This is lease program. We would not be responsible for the equipment needed for a Deputy. This would be included in the lease. It explains overtime, which would be very little overtime. We will pay their benefit expenses. The total benefits and salary for one Deputy would be \$118,698.00. The car, and all the equipment is \$14,061. 31. The total yearly cost would be \$132,760.18.

**Tim Foley** The Deputy would not be on our Health Insurance, and we would not be paying their PERS, they would be an employee of the Clark County Sheriff's Office, so they would be under a contract and basically we would be leasing their services.

Jim Scoby Would that be a 1 year contract?

**John Roeder** Yes, with that lease they would be dedicated to Springfield Township. I would like to try this service and feel it would be beneficial for the Township.

Tim Foley Michael Foley, in your opinion could the Leasing of Law Enforcement be paid directly out of ARP Funding?

Michael Foley yes.

Tim Foley By us not having to pay the person every month, or twice a month, helps us document our spending trail with this funding. So paying this lease in a yearly amount, or semi-annual payment helps with documentation.

Michael Foley Yes, there is a lot of tracking involved with this funding.

Tim Foley It has to be made clear this is not an 8am to 5pm position. We will need coverage when needed.

Jim Scoby That is an issue, we need them available when needed, and communication at our Trustee Meetings.

Tim Foley We have our first installment of \$618,000 from ARP Funding, and none of that has been spent.

Mark Smith We were told we would have the second APR Funding payment by year end.

**Tim Foley** I suggest we consider 1 year or 2 year contract with ARP Funding, and if that goes well we add a Levy on the ballot and let the residents decide to continue or not.

**John Roeder** We could education the Township and show what the service provided with stats.

Michael Foley My advice would be, there is always a burden of proof with the ARP Project. I gave a copy of the Treasuries FAQ sheet, and this will show the current guidelines on how you spend this money. (Exhibit A) The statistics must show an increase in violence. This must be in the Resolution to use ARP money.

#### **Dave Nangle-Jamie Allen**

We are in need of a Fire Engine. Our current truck is reaching 30 years of age. This cost would be approximately \$500,000. If we order this truck now we are looking at 2023 before we would receive it. As of January 1, 2022 we will be looking at a 6% to 8% increase.

Minutes of Meeting Meeting Meeting Meeting Barrett Brothers - We have depleted our fleet by 3 this year, and will need to replace those.

Held Tim Foley The purchase of a new Fire Truck would not be able to be purchased thru ARP Funding but a Medic Truck could be.

Dave Nangle We need to get back into the rotation on vehicles. We are in the need of new units and the pandemic did affect us.

**Jim Scoby** It sounds like ARP Funds will help with the medic equipment needed.

Mark Smith We have 2 Funds that are Capital Funds. I feel we do have the funds to accommodate this request.

**Jim Scoby** If this was paid out of our General Fund, could we be reimbursed out of the ARP Funding?

**Tim Foley** I recommend that the Medic Unit could be paid directly out of ARP Fund, the Fire Truck could be paid out of Fire Funds or the General Fund.

Michael Foley ARP can only be used to reimburse the General Fund.

Jim Scoby ARP would relate better to the Medic Truck.

**Tim Foley** To reimburse the General Fund we need to show a loss in revenue.

Michael Foley When you write a Resolution allocating the money to purchase an Ambulance, you need to specify you are using ARP money to pay for that due to the need caused from the Pandemic, and needed to provide Public Health.

**Tim Foley** We want to spend \$250,000 on a Deputy, and \$300,000 on a Medic Unit, we would have \$700,000 left over.

Dave Nangle We are in a changing world now. We use to have 30 to 40 people coming from home. Getting to calls. We are having problems getting to these calls in our personal vehicles through traffic.

Tim Foley I just want to make sure if we get a vehicle, it would be accessible for whoever needed it and not be parked at someone's residences.

Jamie Allen I think it is about liability stand point.

Dave Nangle We will be continuing our staffing for the department. Transition into Regional Dispatch has not be finalized.

Tim Foley Can Dispatching fees be paid thru ARP Funding?

Michael Foley Dispatching fees can also be paid thru ARP.

Dave Nangle We will be starting the rotation for our Breathing Apparatus. A few Marcs radios will be needed this year. Thermal Imaging equipment will be needed, 4 units will be approximately \$3,000.
