Zoning/Administrator

Jennifer Tuttle There is a Resolution tonight for the GledHill Package for the new dump truck we have on order. This package is at state pricing, so there was no need for the bid process.

We have had discussions about parking in the right of way on Seminole. Deputy Shaw went to this location and took pictures. There is a 25mph sign with a no parking sign under it and there used to be a second No Parking sign on that road but it has been removed. This location was apparently addressed in the past on No Parking, but I was unable to find out when.

We do have a video showing how tight the corner is when someone is parking there.

The Township Trustees according to ORC Code have the right to vote on making this location a no parking roadway. We did post signs and mailed out letters to all properties being affected.

Deputy Shaw With there being a curve at this location, and if there is a car is parked on the roadway, there is a blind spot. If everyone went 25 mph and yielded to the next person there probably would never be an issue, but that doesn't happen. I get multiple speeding complaints in this area. This is a potential for a crash.

Jennifer Tuttle This is based on safety. We have received a few complaints about this issue.

John Roeder There are driveways in this neighborhood.

Brian Jenkins- 1331 Seminole

Just worried about the school bus stopping.

It will not disturb any bus stops, this is just for cars being parked on the roadway at this location.

Brian Jenkins

We have lived at this location for 15 years. I feel no parking on the entire roadway would be too much. It has gotten bad in the last few years and I feel no parking just on the curve would be enough.

Charles Chapsky- 2150 Scioto Dr

The sign that is missing was ran over years ago and never replaced.

Tom Lagos- 750 Shrine Rd

There are no statistics on what actual accidents that have been at this location. There are other ways to address this if there is a problem, you could make it a one way street. I have been involved in real estate with my father since the age of 14, and I have never faced a situation of an elimination of parking in front of 2 of my rentals.

There is no question there are driveways that will accommodate 2 cars. Explained most properties own more than 2 cars in today's society.

The elimination of parking by an ordinance tonight, my wife and I believe it would cost us \$25,000 a unit (at a minimum) in property value.

People want to be able to have adequate parking.

Where are quests going to park?

I can find no history for no parking signs. Again enforce the laws. If they are driving 25 mph there will be no problem.

We request the ordinance be denied.

James Stewart- 445 Woodview Dr

I feel speedbumps would be a solution.

Ed Baker- 2256 Shawnee Ave

I worked for ODOT and if you hit one of the speed bumps with a snow plow it's going do some damage. On that curve, if a car is parked there, there is a blind spot.

Charles Chapsky- 2150 Scioto Dr

Concerning the driveway issue. I have lived there a long time and there has never been an issue until now. I own more than 1 car, so I made my driveway bigger. The bigger vehicles needing down the road, Fire Truck, Ambulance, Trash Truck may not be able to get to a resident if cars are parked on the side of the road.

Brian Jenkins 1331 Seminole Ave

I have seen some graveled areas by the roadway. Is that permitted?

Billy Saunders Road Superintendent would have to approve.

Brian Stevenson- 4315 W National Rd

If you do put no parking on both sides of the road. Bridgewater parks on both sides of the road with only 1 way in.

Establishment of a "No Parking Zone" restricting vehicle parking, stopping or standing at any time along Seminole Avenue (between Valley Street and Shawnee Avenue)

WHEREAS, the Springfield Township Board of Trustees is authorized by Ohio Revised Code 505.17 to regulate vehicle parking within the unincorporated area of the Township; and,

WHEREAS, Ohio Revised Code 4511.07(1) allows further restriction to regulate the parking, standing or stopping of vehicles; and,

WHEREAS, it has been determined vehicle parking on Seminole Ave. creates conflicts for, between, and among emergency, passenger, and service vehicles; and,

WHEREAS, the Springfield Township Board of Trustees has determined a regulation of no parking, standing or stopping of vehicles at any time for Seminole Ave. (between Valley St. and Shawnee Ave.) is necessary to preserve the health, safety, and welfare of Township residents, commuters; and a "No Parking Zone", restricting parking, standing or stopping at any time should be established at the following location:

The entire length of Seminole Ave. from Valley Street to Shawnee Ave., both sides (Exhibit A, solid red line); and,

WHEREAS, notice of this proposed "No Parking Zone," has been posted in conspicuous places along the affected street, and street, and property owners have been notified accordingly;

NOW, THEREFORE, BE IT RESOLVED the Springfield Township Board of Trustees hereby agrees to:

Section 1. Establish a "No Parking Zone", restricting vehicle parking, standing or stopping at any time for both sides of Seminole Ave. from Valley St. to Shawnee Ave., effective 30 days from the date this Resolution is approved and signed.

Section 2. Determine any violation of this parking regulation for the "No-Parking Zone" constitutes a minor misdemeanor.

Section 3. Authorize the Board or its designated agent, Clark County Sheriff's Office, to fine or order into storage any vehicle in violation of this Resolution.


