The reason for the hearing tonight is for our 2025 Tax Budget Hearing. This is for the tax revenue that is being estimated for 2025. These are figures used from our County Auditor. I have a budget using those figures for tonight. If we need to change anything we can, they are estimates at this point.

What you are looking at is the estimated Budget for 2025. (These can be reviewed by the public with the Fiscal Officer by appointment)

ARPA FUND: Currently we have appropriated for 2024: \$745,000 which \$137,000 is for police protection for 2024, we have \$500,000 for the Holiday and Capri Project, and \$108,000 for the Gled Hill Truck for the Road Department, which will leave a balance of \$88,000 for 2025.

We have no Police Protection budgeted for 2025, but we could use the balance from 2024 of \$88,000 for partial payment for 2025. If we are fortunate and our levy passes for Police Protection, we will be able to use the ARPA Fund carryover for another project.

Tim Foley Where do I find the General Fund on the budget sheet?

Mark Smith That is listed on the first page. Each page lists what funds we have, with the current balances and expenditures for next year, leaving what we estimate for our balance carryover.

Mark Smith discussed all funds with the Trustees

Jim Scoby Our debts should be paid off in a few years, correct?

Mark Smith Our debt on the building will be paid off at the end of 2026. After that we will have no debt service.
