Administrator/Zoning

Jennifer Tuttle Stated Gage Jenkins, our intern, is covered by a Grant thru December 2024, and there may be another Grant available at the first of the year for 2025.

Form Fire has been completed for Health Insurance.

The camera cost to replace NVR Boxes and 2 additional cameras is \$13,000.

AED Defibrillator for the shelter house is needed and electric will need to be run. The cost on the AED Defibrillator is \$3,182.00 and that doesn't include running the electric back to it. We will need to make sure it is protected.

Trustees discussed the location and cost for the AED Defibrillator.

I have been looking at alternatives for communication with residents. There is an internet based company called TextMyGov. There are a few Townships currently using this program. It is a texting capability with residents where they can opt in and receive texts when it is road related, Fire EMS, etc.

We do not have the medic back yet. There were a few issues with the repairs.

Interviews have started with the Road Department.

142 Highview was declared a nuisance by the Health Department and the Township agreed to pay half of that cost which is approximately \$900.
